Mineral Site Allocation, Parley Court Farm. [Stour Valley]

In the summer edition of our newsletter we reported on the latest development regarding the application for mineral extraction at Parley Court Farm. For information, in representations by Cllr. Ron to Dorset County Council in November last year, a detailed response was that the Government office had advised Dorset to concentrate on the minerals core strategy at present, and further advised that Parley Court is one of over forty sites that have been suggested, and we are awaiting more detailed information on many of these suggested sites, Dorset County Council 14th Jan 10 in an e-mail to Cllr Ron said the following: "Thank you for forwarding these photographs, will ensure they are made available to whoever will be preparing our Strategic flood risk assessment. As I have said in earlier e-mails, we are still waiting for locations of any bunding and plant from the company suggesting this site [there is, of course, no planning application]. I would be very surprised if the EA agree to any bunding alongside the river"

Berry Hill Sludge Treatment Centre, Throop

Residents living in the Throop area have been kept informed over the last year of the ongoing and detailed representations we have been making to Wessex Water regarding the number of times the treatment centre at POOLE which have failed and resulted in increased 12 wheeled tanker movements into and out of Berry Hill, added to which have been open sheeted lorries. In considerable and lengthy correspondence with the Chairman of Wessex Water and OFWAT of the need to take action that will reduce these endless daily tanker movements and, more so, as Berry Hill has to take sludge from as far as Weymouth, Palmersford, and Christchurch - all these tanker movements take place on a very overcrowded Castle Lane West. On 15th September Cllr. Ron put forward a Council motion for the need for investment of a pipeline into Berry Hill that would bring enhanced service to customers through the cessation of liquid sludge imported tanker movements daily through the local network, plus the traffic reduction arising from the proposed investment, including environmental benefits to those local residents from reduced vehicle emissions and noise. We are pleased to say the motion was carried unanimously. We are also pleased to report that the business case put forward by Wessex Water to Ofwat was CONFIRMED in December; we are now awaiting details of the proposals/scheme.

Just a few of many local issues receiving our attention at present:

Traffic Lights, Muscliff Lane. We were promised in November last year that the sequencing of the traffic lights in Muscliff Lane would be carried out. We have now been told these works/improvements are planned in mid/late January. With the present situation, as many motorists have found, traffic is often unable to clear the junction due to the traffic already on Castle Lane West which backs up to the lights on Wimborne Road; again, please see our website.



Throop Hatches [Sluice Gates] and PATH from the Hatches to the Weir Bridge. With the delays to the major repair works to the sluice gates due to the weather conditions, work has now re-started in January as informed by the Environment Agency. Nevertheless, the good news is that the works associated with the modification and repairs to the steel plates are underway in the workshops. Here again the FOOTPATH running from the Hatches to the weir bridge [which as we all know from our visits/lovely walks in the Stour Valley, the path has become difficult and very muddy] work has been approved by Dorset County Council for surfacing this path and to carry out repairs to the path running parallel to the river from the weir bridge, south-eastward to the pedestrian gate into the field. All this area comes under Dorset County Council.

Potholes. Yes, this has become a major headache for many motorists/cyclists, particularly in Throop Road and Muscliff Lane, where all have been brought to the attention of the Highways Department. We continue in our regular travels around the Ward to report any potholes and those that residents bring to our attention.

Road Signage. We had representations for a missing road sign for Throopside Avenue and requests for Sandringham Close to be INCLUDED in the present road sign, which are being undertaken.

Bus Shelter adjacent to John Pound House. After receiving representations from Judy Walker of John Pounds House and our PCSO, Anna, that residents of the home would like a bus shelter in the location to the existing Bus Stop. We were able, with the support of a £1,000 contribution from our Ward fund, to have a relocation of the present Bus Shelter from the Triangle which had become redundant due entirely to the present road being closed off now to traffic and buses. Delighted to see the bus shelter now in place.
